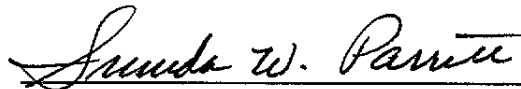
The Board of Directors shall have the authority to adopt and periodically amend the bylaws of the Corporation.

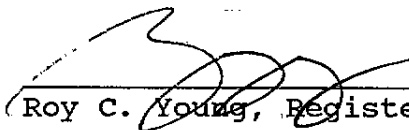
