

ARTICLES OF INCORPORATION
OF

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: PRO-IMAGE CLEANING COMPANY, INC.

ARTICLE II. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

ARTICLE XI. INDEMNIFICATION




