

## ARTICLES OF INCORPORATION OF CLEAR IDEA SOFTWARE, INC.



### ARTICLE 1. - NAME

The name of the Corporation is CLEAR IDEA SOFTWARE, INC..

### ARTICLE 2. - PRINCIPAL OFFICE
