We, the undersigned, hereby associate ourselves together for the purpose of organizing a corporation in accordance with the laws of the State of Florida.

**Article One**  
**Name**

**Duration**

The period of existence of the corporation is perpetual.

**Article Three**  
**Principal Office and Mailing Address**
