ARTICLES OF INCORPORATION OF WINEBARGER, INC.

The undersigned subscriber to these Articles of Incorporation, Diana DormaWinebarger, being a natural person competent to contract, hereby acknowledges and files
these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State
of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is WINEBARGER, INC. The principal office and mailing address of the corporation is 535 9th Street North, Naples, Florida 34108.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.
