

ARTICLE I

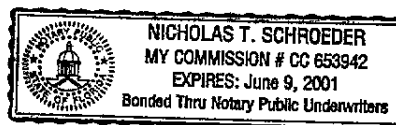




