**ARTICLES OF INCORPORATION**  
**OF**

**Tracy J. Sumner, P.A.**

THE UNDERSIGNED, for the purpose of beginning a Corporation under the laws of the State of Florida, Chapter 607, General Corporation Act, and Chapter 621, Professional Service Corporations, providing for the formation, liabilities, rights, privileges and immunities of a Corporation for profit generally and hereby makes, subscribes, acknowledges and files these Articles for the purpose of becoming a Corporation under the laws of the State of Florida.

**ARTICLE I**

**Name of Corporation**

The name of this Corporation shall be Tracy J. Sumner, P.A. The address shall be 1330 Thomasville Road, Tallahassee, Florida, 32303.

**ARTICLE II**

**General Nature of Business**

The general nature of the business to be transacted by this Corporation shall be:

- (1) To engage in the business of practicing law.
- (2) To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation and to guarantee contracts and other obligations.
- (3) To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interest of this corporation, and to do all things specified in the Florida Statutes and

to have and to exercise all powers conferred by the laws of the State of Florida on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations, and in any part of the world.

The foregoing statement of purposes shall be constructed as a statement of both purposes and powers, shall be liberally constructed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in nowise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be constructed distributively as each object expressed, and the enumeration as to specific powers, shall not be constructed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

### ARTICLE III

#### Capital Stock

(a) The total number of shares of capital stock authorized to be issued by the Corporation shall be 50 shares.

(b) The holders of the stock of a Corporation shall not have the preemptive right to subscribe for and purchase any proportionate share of any additional stock issued by the corporation from and after issuance of the shares originally subscribed for by the shareholders of this Corporation, whether such additional shares be issued for cash or property, and whether or not such shares be presently authorized or be authorized by subsequent amendment to these Articles of Incorporation.

#### **ARTICLE IV**

##### **General Powers**

In furtherance and not in limitation of the general powers conferred by the laws of the State of Florida and of the purposes and objects hereinabove stated, the Corporation shall have all the following powers:

(a) To enter into, or become a partner in, any arrangement for sharing profits, union of interest, or cooperation, joint venture or otherwise, with any person, firm, or corporation.

#### **ARTICLE V**

##### **Amendment**

These Articles of Incorporation may be amended in the manner provided by law.

#### **ARTICLE VI**

##### **Initial Registered Office and Registered Agent**

The address of the initial registered office of the Corporation in the State of Florida is 1330 Thomasville Road, Tallahassee, Florida 32303.

The registered agent of the Corporation at the registered office of the Corporation is Tracy J. Sumner.

#### **ARTICLE VII**

##### **Existence of Corporation**

This Corporation shall commence business upon the filing of these Articles with the Secretary of State of Florida on February 2, 1998, and shall exist perpetually thereafter unless dissolved according to law.

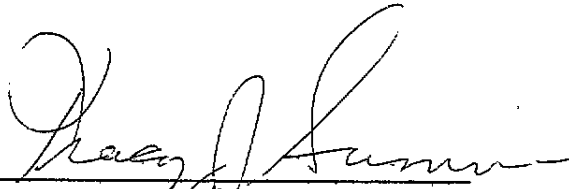

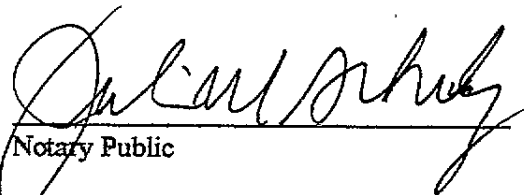

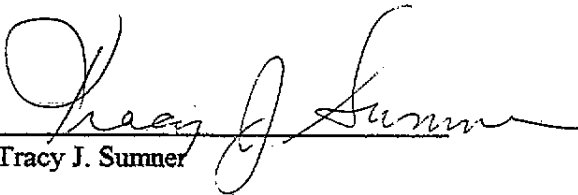
