ARTICLE I - NAME

The name of this corporation is PRETREATMENT & PROCESS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on January 27, 1998.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing consulting services for pretreatment for painting and powder coating and for transacting any or all lawful business as allowed under the laws of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock, which shall be designated "common shares".

This corporation reserves the right to amend or repeal any amendment hereto, and any right, conferred upon the shareholders is subject to this reservation.

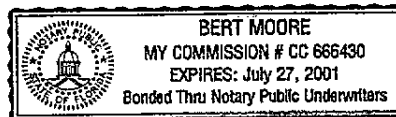
