ARTICLES OF INCORPORATION
OF
CARDIOVASCULAR CONSULTANTS OF TAMPA BAY, P.A.

The undersigned subscriber hereby files these Articles of Incorporation with the Secretary of State of the State of Florida, for the purpose of forming a professional service corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act (the "Act"), Chapter 621 of the Florida Statutes.

ARTICLE ONE
NAME AND MAILING ADDRESS OF CORPORATION

The name of this corporation is Cardiovascular Consultants of Tampa Bay, P.A. (the "Corporation"). The mailing address of the Corporation is 2727 West Martin Luther King Boulevard, Suite 800, Tampa, Florida 33607.

ARTICLE TWO
CORPORATE PURPOSE/OWNERSHIP LIMITATION

The Corporation is being formed to provide medical services and to engage in any other activities permitted by the Act. If any member, officer, shareholder, agent, or employee of the Corporation, who has been rendering professional services to the public becomes legally disqualified to render such professional services within this State or accepts employment that, pursuant to existing law, places restrictions or limitations upon that person's continued rendering of such professional services, that person shall sever all employment with, and financial interests in the Corporation.

ARTICLE THREE
CAPITAL STOCK

The Corporation is authorized to issue 100,000 shares of \$.01 par value common stock.

ARTICLE FOUR
CORPORATE EXISTENCE AND DURATION

The period of duration of the Corporation shall be perpetual commencing on the date of execution and acknowledgement of these Articles.

ARTICLE FIVE
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

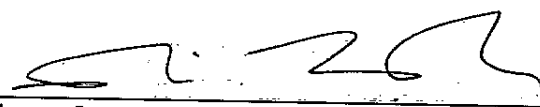
The street address of the initial registered office of the Corporation is 201 N. Franklin Street, Suite 2600, Tampa, Florida

The name and street address of the incorporator is Ricardo A. Roig, Esq., 201 N. Franklin Street, Suite 2600, Tampa, Florida 33602.

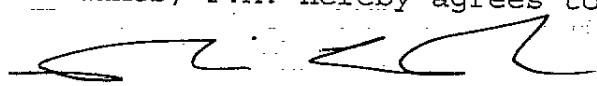
