The undersigned subscriber hereby files these Artistes of Incorporation with the Secretary of State of the State of Plorida, for the purpose of forming a professional service corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act (the "Act"), Chapter 621 of the Florida Statutes.

ARTICLE ONE NAME AND MAILING ADDRESS OF CORPORATION

The name of this corporation is Cardiovascular Consultants of Tampa Bay, P.A. (the "Corporation"). The mailing address of the Corporation is 2727 West Martin Luther King Boulevard, Suite 800, Tampa, Florida 33607.

ARTICLE TWO CORPORATE PURPOSE/OWNERSHIP LIMITATION

ARTICLE THREE CAPITAL STOCK

The Corporation is authorized to issue 100,000 shares of \$.01 par value common stock.

ARTICLE FOUR CORPORATE EXISTENCE AND DURATION

The period of duration of the Corporation shall be perpetual commencing on the date of execution and acknowledgement of these

ARTICLE FIVE INITIAL REGISTERED OFFICE AND REGISTERED AGENT
