ARTICLES OF INCORPORATION

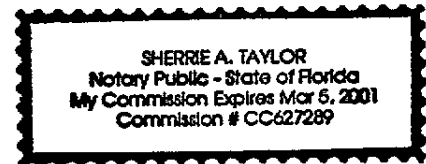


