The amendment was adopted on the 1st day of August, 2006.

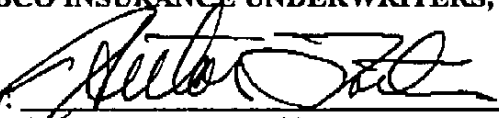
ARTICLE IV
