#### ARTICLES OF INCORPORATION

#### ARTICLE I. CORPORATE NAME

The name of this corporation is: --(1)-- Hathaway's Boat Rentals, Inc.

## ARTICLE II. NATURE OF BUSINESS AND POWERS
