# TALLAHASSEE, FLORIDA

The undersigned subscriber to these Articles of Incorporation, a natural person

competent to contract, hereby forms a corporation under the laws of the State of Florida.

## **ARTICLE I - NAME**

The name of the corporation is: A. BÄRTSCHI FLORIDA, INC.

#### ARTICLE II - DURATION OF CORPORATE EXISTENCE

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.
