## ARTICLES OF INCORPORATION

OF

S.M.N. ENTERPRISES, INC.

BY THESE ARTICLES OF INCORPORATION the Incorporator forms a Corporation for profit under Florida law:

### ARTICLE I.

The name of the Corporation is S.M.N. ENTERPRISES, INC.

The name and address of each member of the First Board of Director is:

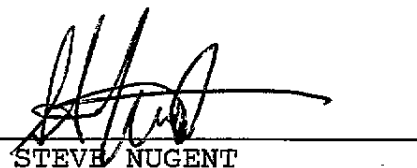

ARTICLE VIII.

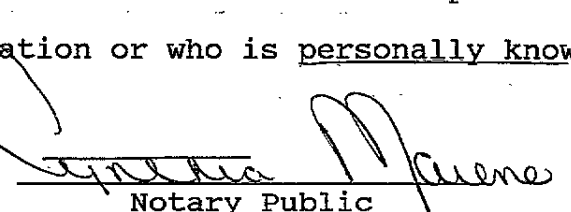

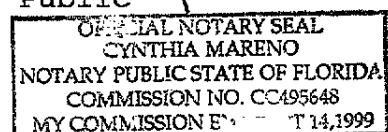
