The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be **YOUR KIND OF TREE SERVICE, INC.** and the principal place of business of this corporation shall be 5323 25th Street West, Bradenton, Florida 34207, and the mailing address of the corporation shall be 5323 25th Street West, Bradenton, Florida 34207.

ARTICLE II: NATURE OF BUSINESS

This corporation shall engage in all aspects of the business of a tree service and otherwise to engage in any other business that is for lawful purposes for which the corporation may be permitted by law pursuant to Chapter 607, Florida Statutes (1994).




