## ARTICLES OF INCORPORATION **OF**

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General ALLAHASSEF EL SALE Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the Corporation is dotCOM 2000, Inc.

ARTICLE II

The duration of the Corporation is perpetual.

#### ARTICLE III

The general purpose for which the Corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Florida General Corporation Act.
