The undersigned subscriber for the purpose of forming a corporation under the
Florida General Corporation Act, does hereby adopt the following articles of
incorporation:

ARTICLE I

The name of the Corporation is FIRST FARM LOAN & ASSOCIATES, INC., a
Florida corporation.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The general purposes for which the corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under
the Florida General Corporation Act.
2. To do such other things as are incidental to the foregoing or necessary or desirable
in order to accomplish the foregoing.

ARTICLE IV

The aggregate number of shares which the corporation is authorized to issue is 300.
Such shares shall be of single class, and shall have a par value of One Dollar (\$1.00) per
share.

ARTICLE V

The street address of the initial registered office and the corporation's principal office


