Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the followings Articles of Amendment to its Articles of Incorporation:

FIRST: ARTICLE II and ARTICLE IV are hereby amended by changing the address of the principal place of business and the resident agent to 9240 Rhea Drive, Odessa, Florida 33556.

SECOND: ARTICLE III is hereby amended by deleting the current ARTICLE III in its entirety and substituting therein the following:

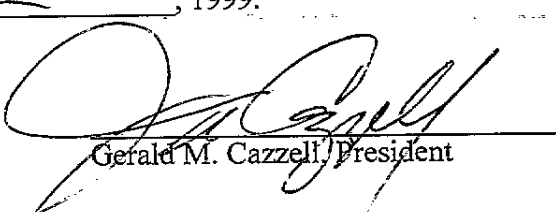
The number of shares of stock that this corporation is authorized to have outstanding at any one time is: 10,000,000 shares of \$.0001 par value common stock. Each share of the issued and outstanding common stock will after the approval of these Articles of Amendment be converted into 1,000 shares of the \$.0001 par value stock.
