1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be MARX ARMORY, INC. and its address is 3219 Highway 390, Panama City, Florida 32405.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.


