**ARTICLE I - NAME**

**THE NAME OF THIS CORPORATION IS:**


## **ARTICLE XI - PRE-EMPTIVE RIGHTS**

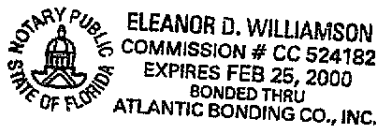



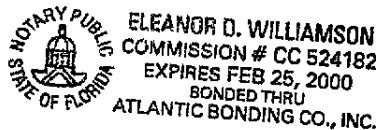
