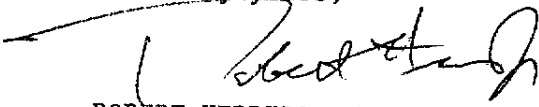

The name of the corporation is D. S. L. Communication Enterprises, Inc. (hereinafter called the "Corporation").

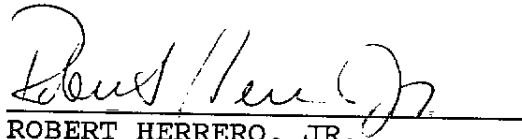
ARTICLE VI

This Corporation shall indemnify and advance expenses on behalf of its officers and directors to the fullest extent permitted by law in existence either now or hereafter.

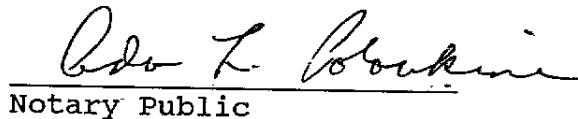
