ALCON TO MILION In compliance with the requirements of F.S. Chapter 607, undersigned, SHANNON R. SCHWENN, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is SHANRONN INDUSTRIES, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III


