The power to adopt, alter, or repeal bylaws shall be vested in the board of directors and the shareholders.

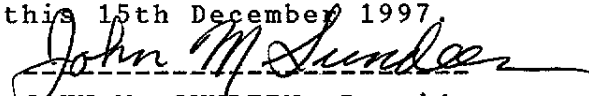
#### ARTICLE IX - Indemnification

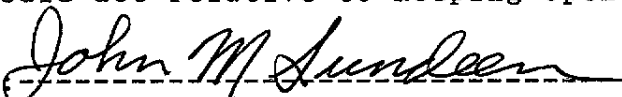
