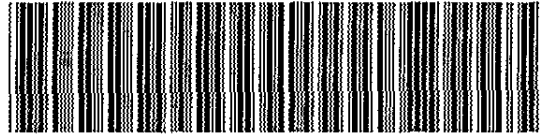

THIS MATTER came to be heard on Respondent, C. Timothy Riordan's Motion for Partial Summary Judgment and after being advised of the premises, it is hereby

ORDERED and ADJUDGED that:

1. C. Timothy Riordan's Motion for Partial Summary Judgment is hereby  
GRANTED.

2. Alternative Security Solutions, Inc., a Florida Corporation, is hereby dissolved

pursuant to section 607.1430, Florida Statutes; *subject to reports and recommendations*


*as to distribution of assets and liabilities from the corporate*  
*custodian to be selected by agreement of the parties or by Court,*  
*in the event no agreement on the appointment is reached by*  
*the parties.*

3. A custodian shall be appointed to assist in winding down the corporation and to account for any liabilities and assets which may be apportioned among the shareholders.

4. Petitioner, Peter Rayner, and Respondent, C. Timothy Riordan, have five days from the date of this order to agree on a custodian. If this cannot be accomplished, the Court will thereafter appoint a custodian.

5. The custodian shall report the corporation's status to the Court within twenty days of appointment.
