ARTICLE I. Name

The name of the corporation shall be:

ARTICLE II.
Nature of Business

This corporation may engage on transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

> ARTICLE III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$5.00 (Five Dollars) par value. 
