**Article I - Name and Address**

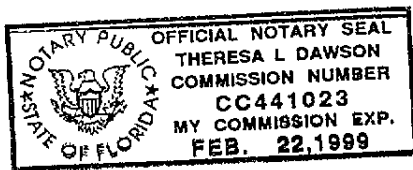


