

## ARTICLES OF INCORPORATION

#### **FOR**

## UP TO DATE AGAIN, INC.



The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby do adopt the following Articles of Incorporation.

## ARTICLE I

The name of the corporation is Up To Date Again, Inc.

## ARTICLE II

## TERMS OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles or upon filing with the Secretary of the Sate of Florida, in the event these Articles are not filed within five (5) days, exclusive of legal holidays, after execution and acknowledgment.

#### ARTICLE III

#### NATURE OF BUSINESS

The general purpose for which the corporation is organized are:

- (a) To operate and function as a consignment shop.
- (b) To carry on such other business as may be necessary, convenient, or desirable to accomplish the purpose state in paragraph (a).
- © To transact any other lawful business for which corporations may incorporate under the Florida General Corporation Act or engage in any other trade or business which can in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

## CAPITAL STOCK
