Please be advised that we have been asked to write on behalf of the above captioned corporate entity. The corporation was formed on February 8, 1998.

Although the address appears to be correct in the Articles of Incorporation, the entity did not receive an annual report in the mail. Furthermore, because an annual report was not received and this is the first year since the incorporation, the officer was not aware of the requirement to file. He only became aware when he came into our office for accounting and tax work. Upon our inquiry, we ascertained no corporate annual report had been filed (we became suspicious when the officer, Joe Rivel, did not know what we were talking about).

We have enclosed a report, together with our check in the amount of \$150.00 in payment of the fees. We respectfully petition that the late charges of \$400.00 be waived. As set forth previously, this is the first year the corporation has been required to file and had not received the filing package. There has been no intentional disregard for the requirement.
