In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a corporation, which elects to be treated for tax purposes, under subchapter "S" of the Federal Internal Revenue Code.

**ARTICLE I**
