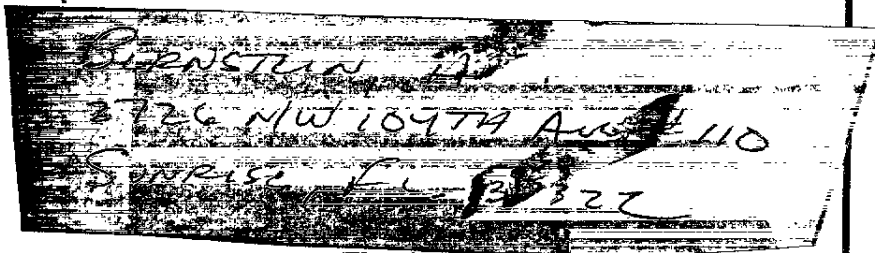

ARTICLE I - CORPORATE NAME

The name of the corporation is CUSTOM DETAILING, INC.

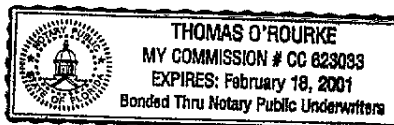
