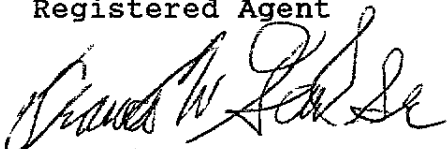

ARTICLE VIII. INDEMNIFICATION

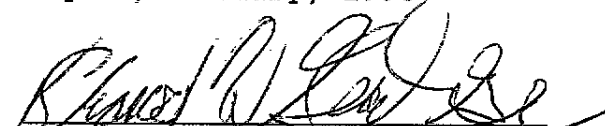
The corporation shall indemnify any officer or director or any former officer or director to the fullest extent permitted by law.

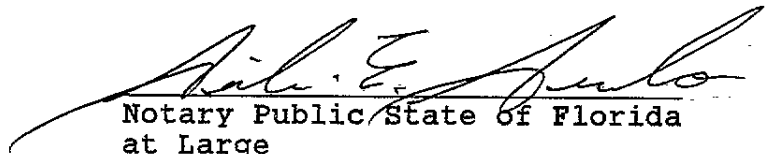
