The undersigned Subscriber, whom is licensed real estate agent, desiring to form a corporation in the State of Florida hereby makes, signs, and subscribes these Articles of Incorporation in order to form a professional corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is TIM MCKERNAN, P.A., hereinafter referred to as the "Professional Association".

ARTICLE II - NATURE OF BUSINESS
