

ARTICLES OF INCORPORATION of SOUTHWEST AUTOMATION, INC.

ARTICLE I - NAME

The name of this corporation is SOUTHWEST AUTOMATION, INC.

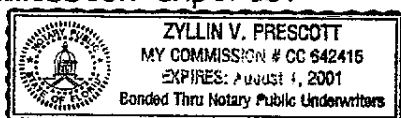
