ARTICLE ONE - NAME

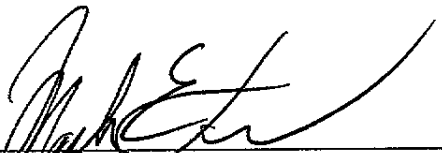
ARTICLE TEN

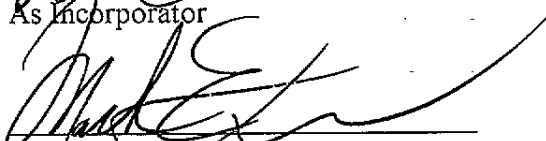
ARTICLE ELEVEN - AMENDMENTS
