Certificate of Incorporation

Of JOSE DIAZ ARVESU, INC
We, the undersigned, hereby associated ourselves together for the purpose of becoming a corpo- ation under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of ncorporation for profit.
Article I

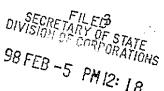
