

The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND BUSINESS MAILING AND PRINCIPAL BUSINESS OFFICE

ADDRESS

The name of this corporation is **INTERSTATE INSTALLATIONS AND MAINTENANCE, INC.** The business mailing address and the principal business office address of the corporation is: 1807 6th Avenue North, Lake Worth, Fl. 33461.

ARTICLE II - DURATION

This corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the State of Florida and the United States of America.

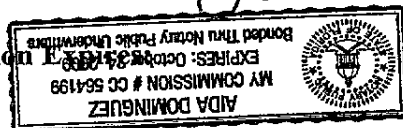



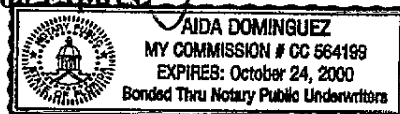
