**ARTICLE I
CORPORATE NAME**

The name of this Corporation shall be:

SUNSET SERVERS OF CENTRAL FLORIDA, INC.

**ARTICLE II
INITIAL PRINCIPAL OFFICE**

The initial principal office and post office address of the Corporation shall be 801 S. University Dr., Suite 500, Plantation, FL 33324. The Board of Directors may, at any time and from time to time, move the principal office of the Corporation to any location within or without the State of Florida.

**ARTICLE III
NATURE OF CORPORATE BUSINESS**

The Corporation may engage in any activity or business, permitted under the laws of the United States and under the laws of the State of Florida.

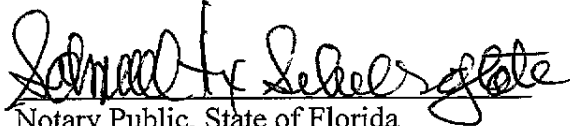

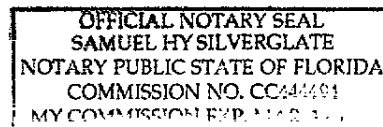
