The name of this corporation is **R & C DEFERRARI MANAGEMENT, INC.** ("Corporation").


ARTICLE IX. INDEMNIFICATION

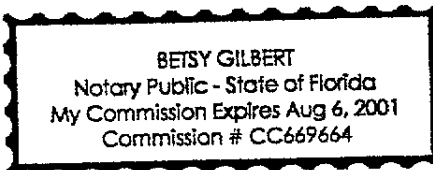
