ARTICLE I. NAME

The name of this corporation is ATRIUM ENTERPRISES OF

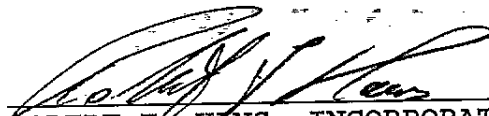

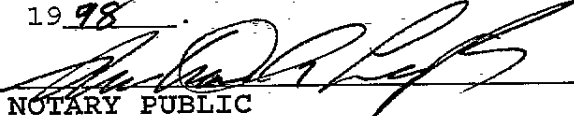
