ARTICLE I. NAME

The name of the Corporation is ANNE JENEANNE MURPHY, P.A.

ARTICLE II. DURATION

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the State of Florida. The specific purpose of the corporation is to transact real estate sales, travel sales and membership sales in a timeshare exchange company.

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares on one dollar (\$1.00) per value common stock.

ARTICLE V. MANAGEMENT

A. Pursuant to the provisions of Section 607.111 Florida Statutes, as the same exists upon the adoption of these Articles of Incorporation, the business of this Corporation may be managed by the shareholders of the Corporation, rather than by a Board of Directors.

B. Should the shareholders of the Corporation so elect, they may by resolution and bylaw establish a Board of Directors to manage the business of this Corporation. In such event, the shareholders shall prescribe the duties, functions and methods of operation of such Board of Directors with particularity and appropriate bylaws.

ARTICLE VIII. PRE-EMPTIVE RIGHTS




