ARTICLE I - NAME

THE NAME OF THIS CORPORATION UNDER CODE SECTION 621 OF FLORIDA STATUTES IS EDITH HELNA FORCE, P.A.

ARTICLE II - PURPOSE

THIS ORGANIZATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING BUSINESS AS A LICENSE REAL ESTATE PERSON.

ARTICLE III - DURATION

THIS CORPORATION SHALL HAVE A PERPETUAL EXISTENCE COMMENCING ON THE DATE OF THIS FILING OF THESE ARTICLES OF INCORPORATION.

ARTICLE IV -CAPITAL STOCK

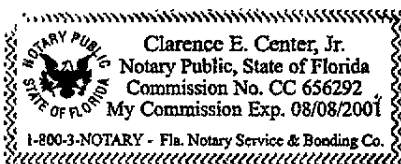
