ARTICLE I - NAME

ARTICLE III - PURPOSE

This corporation is organized for the purpose of rendering specific professional service as medical doctors.

ARTICLE IV - CAPITAL STOCK

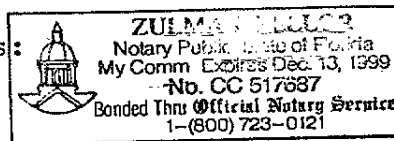
