I am the primary owner of the above referenced corporation. I have become aware that it has been administratively dissolved since September 22, 2000 for non-filing of the required Florida Corporation Annual report. I am submitting a corporate reinstatement form with payment of \$300.00, to cover the two years not filed.

I am respectfully requesting an administrative waiver of the \$600.00 reinstatement fee for the reason that I never received the appropriate forms for filing. I am a US citizen living in Chile, South America. My Florida based attorney, Morton R. Goudiss, originally set up this corporation for me, naming himself as registered agent, and using his own address as the corporations business and mailing addresses. I relied on him to prepare and forward to me for signature, in Chile, any forms or documents necessary to keep the corporation in good standing with the State of Florida. As of the date of this filing, I have received no such documents from Mr. Goudiss.

Additionally, I have been informed that there also exists a conflict of interest between Mr. Goudiss and me. It has come to my attention that Mr. Goudiss, also a distant family member by marriage, has, and is representing certain of my family members in potential litigation against me.

For these reasons, I again respectfully request an administrative waiver of the \$600.00 reinstatement fee. Thank you in advance for your cooperation in this matter.
