**ARTICLES OF INCORPORATION OF
ADVANCE NOTIFICATION SERVICE, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is Advance Notification Service, Inc. The principal office and mailing address of the corporation are: 1423 Wakefield Drive, Brandon, Hillsborough County, Florida 33511.

Article II

The duration of the corporation is perpetual.

Article III

The general purpose of the corporation is to engage in and transact all business which is lawful under the laws of the United States of America and the State of Florida.

Article IV

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. All such shares shall be of a single common class. Each share shall have a par value of one cent (\$.01).

Article V

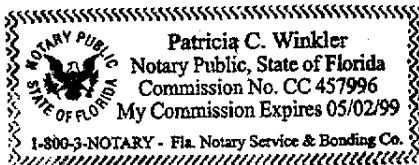
