Articles of Incorporation
of
S.J.K. Services, Inc.

Article I - Name

The name of the corporation is: S.J.K. Services, Inc.

Article II - Duration

This corporation shall exist perpetually.

The name and address of the person signing these Articles of Incorporation is: Paul S.King, at 6937 Stapoint Court, Winter Park, Florida 32792.


Article IX - Initial Officers
