**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of the corporation is LONE STAR AUTO COLLISION, INC. And principal place of business shall be located at 2585-C Forsyth Road, Marlon Industrial Park, Orlando, Florida 32807.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one hundred (100) shares of common stock at Ten Dollars (\$10.00) par value, which shall be designated as "Common Shares."

**ARTICLE V - PREEMPTIVE RIGHTS**
