

ARTICLES OF INCORPORATION
OF

The undersigned Incorporator to these Articles of Incorporation, a natural person content to contract, hereby forms a corporation under the laws of the State of Florida, as follows:

ARTICLE I

The name of the Corporation shall be JNH AVIATION, INC. and principal office and registered office are the same at 2555 SE DIXIE HIGHWAY, SUITE #124 STUART, FL 34996

ARTICLE II

The purpose of the Corporation is to engage in the activity or business of AIRCRAFT PURCHASES AND SALES according to the laws of the United States and the State of Florida.



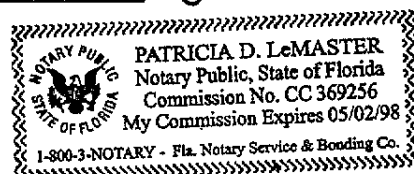
