ARTICLE I. NAME

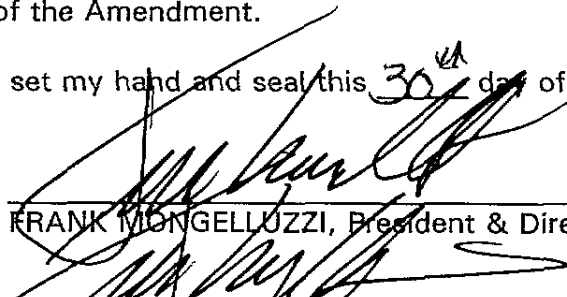
The name of the corporation shall be: "LTS Services, Inc."
