

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I. Name.** The name of the Corporation shall be:  
C.B.B.P., INC. ("Corporation").

**Article V. Incorporator.** The name and street address of the person signing the Articles of Incorporation is:


